

## **FAITH CHAPEL OF CARLISLE HOLD HARMLESS WAIVER**

The **Parishioner** named below (referred to as "I" or "me") desires to participate in church services and related activities (the "**Services**") at Faith Chapel of Carlisle, located at 1453 Holly Pike, Carlisle, Pennsylvania 17015 (the "**Church**") during the COVID-19 reopening phase established by the Commonwealth of Pennsylvania.

As lawful consideration for participating in the Services at the Church, the receipt of which is hereby acknowledged, I agree to all the terms and conditions set forth in this waiver (this "**Waiver**").

I AM AWARE AND UNDERSTAND THAT PARTICIPATING IN SERVICES AT THE CHURCH MAY INVOLVE THE RISK OF CONTRACTING COVID-19 OR RELATED VIRUSES. I ACKNOWLEDGE THAT I AM VOLUNTARILY PARTICIPATING IN THE SERVICES WITH FULL KNOWLEDGE OF THE RISK INVOLVED AND HEREBY AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS OF INFECTION OF COVID-19.

I AM AWARE AND UNDERSTAND THAT I HAVE THE OPTION TO PARTICIPATE IN THE SERVICES REMOTELY VIA SERMON AUDIO OR FACEBOOK LIVE AND AM NOT BEING REQUIRED OR COMPELLED TO PARTICIPATE IN THE SERVICES AT THE CHURCH.

I AM ALSO AWARE AND UNDERSTAND THAT, IF APPLICABLE, PARTICIPATING IN THE SERVICES REMOTELY WILL NOT JEOPARDIZE OR COMPROMISE MY MEMBERSHIP STATUS WITH THE CHURCH IN ANY WAY.

I EXPRESSLY WAIVE AND RELEASE ANY AND ALL CLAIMS, NOW KNOWN OR HEREAFTER KNOWN, AGAINST THE CHURCH, AND ITS OWNERS, OFFICERS, DIRECTORS, TRUSTEES, EMPLOYEES, AGENTS, AFFILIATES, SUCCESSORS, AND ASSIGNS (COLLECTIVELY, "**CHURCH TEAM**") ARISING OUT OF OR ATTRIBUTABLE TO VISITING THE CHURCH AND PARTICIPATING IN THE SERVICES ON OR ANY TIME AFTER THE DATE OF THIS WAIVER SET FORTH BELOW. I COVENANT NOT TO MAKE OR BRING ANY SUCH CLAIM AGAINST THE CHURCH OR ANY OTHER MEMBER OF THE CHURCH TEAM, AND FOREVER RELEASE AND DISCHARGE THE CHURCH AND ALL OTHER MEMBERS OF THE CHURCH TEAM FROM LIABILITY UNDER SUCH CLAIMS.

This Agreement constitutes the sole and entire agreement of the Church and me with respect to the subject matter contained herein and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to such subject matter.

If any term or provision of this Waiver is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Waiver or invalidate or render unenforceable such term or provision in any other jurisdiction.

This Waiver is binding on and shall inure to the benefit of the Church and me and our respective successors and assigns. All matters arising out of or relating to this Waiver shall be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania without giving effect to any choice or conflict of law provision or rule, whether of the Commonwealth of Pennsylvania or any other jurisdiction.

Any claim or cause of action arising under this Wavier may be brought only in the federal and state courts located in and for Cumberland County, Pennsylvania and I hereby consent to the exclusive jurisdiction of such courts.

**BY SIGNING, I ACKNOWLEDGE THAT I HAVE READ AND UNDERSTOOD ALL OF THE TERMS OF THIS AGREEMENT AND THAT I AM VOLUNTARILY GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE CHURCH.**
